

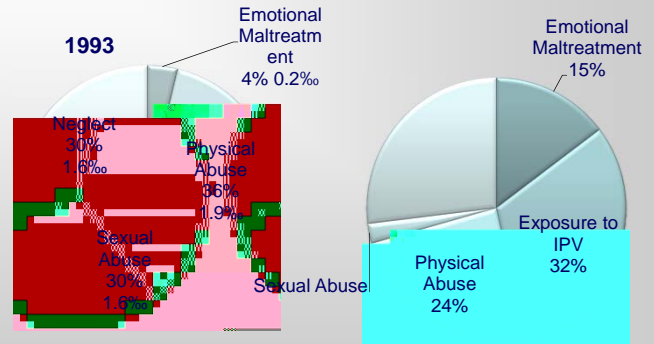

### Emotional maltreatment & other maltreatment investigations CIS 08

<b>All investigations</b>	26,329 (4.37)	148,082 (24.58)	174,411 (28.96)
<b>Substantiated investigations</b>	11,213 (1.86)	74,227 (12.33)	85,440 (14.19)
<b>Rate of substantiation</b>	43%*	50%	49%

†: Substantiated physical abuse, sexual abuse, neglect, and exposure to violence cases that did not involve EM. Cases involving substantiated EM as a primary or second or third form of maltreatment were classified as "Any EM"

Child aggression, suicide thoughts, self-harm, YCJA, multiple runs, substance abuse	39%*	24%
Multiple family moves	12%	10%

### Comparison of forms of EM CIS-98 / 03 / 08

CIS-98 & CIS-03	CIS-08
<p><b>Emotional Abuse:</b> The child has suffered or was at substantial risk of suffering from mental, emotional, or developmental problems caused by overtly hostile, punitive treatment, or habitual or extreme verbal abuse (threatening, belittling, etc.).</p>	<p><b>Terrorizing or threat of violence:</b> A climate of fear, placing the child in unpredictable or chaotic circumstances, bullying or frightening a child, threats of violence against the child or child's loved ones or objects.</p> <p><b>Verbal abuse or belittling:</b> Non-physical forms of overtly hostile or rejecting treatment. Shaming or ridiculing the child, or belittling and degrading the child.</p> <p><b>Isolation/confinement:</b> Adult cuts the child off from normal social experiences, prevents friendships or makes the child believe that he or she is alone in the world. Includes locking a child in a room, or isolating the child from the normal household routines.</p> <p><b>Exploiting or corrupting behaviour:</b> The adult permits or encourages the child to engage in destructive, criminal, antisocial, or deviant behaviour.</p>
